December 28, 2021 Commissioners Meeting

Minutes

A meeting of the Board of Commissioners of Colfax County, Nebraska was held in the Commissioners Room of the County Courthouse, Schuyler, Nebraska on the 28th day of December 2021. The County Board of Commissioners met at 8:30 a.m. Present were: Carl Grotelueschen, Jim Mejstrik and Terry V. Wendt, County Commissioners and Rita M. Mundil, County Clerk. Notice of this meeting was given in advance thereof by posting written notice in at least three different public places as shown by the Certificate of Posting Notice. Availability of the proposed agenda was communicated in the advance notice and in the notice to the board. Copies of the Open Meetings Act were posted and available to the public. All proceedings shown were taken while the meeting was officially convened and open to the public.

The chairman stated a copy of the Open Meeting Act statute is posted and available to the public.

Motion Mejstrik; second Wendt to approve the agenda. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

Motion Wendt; second Mejstrik to approve the minutes of 12/14/2021. Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

The clerk provided the fund balance, October Lodging Tax Revenue and STOP Revenue received.

The October inmate log from Platte County was provided to the board and placed on file.

The treasurer provided a change of safekeeping receipt from Homestead Bank.

Public comment on County Road 17 was made.

The county attorney entered the meeting at 8:45 a.m.

The county attorney gave a report of the activities of her office. Discussion was held to allow the county attorney to pursue the application for a United Way Innovation Grant for Victim-Youth mediation.

The county attorney reviewed the 2023 Community-Based Juvenile Service Aid EB application with the board. Motion Mejstrik; second Wendt to authorize the chairman to sign the 2023 Juvenile Service Aid EB Grant application with the crime commission for the Community-Based Grant for the amount of \$50,750.00. Voting YES: Wendt, Grotelueschen and Mejstrik. Voting NO: None. Motion carried.

The county attorney reviewed the amended State Grant Award for Grant Number 22-CB-505 for Grant Award Period July 1, 2021 – June 30, 2022 which is awarding more grant funds. Motion Grotelueschen; second Wendt to authorize the chairman to sign the amended State Grant Award for Grant Number 22-CB-505 allotting 22-CB-505 \$57,210.00 and 22-EB-606 \$38,536.00 totaling award amount \$95,746.00. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

At the December 14th meeting the board approved to participate in the Opioids Settlement and made a motion to authorize the chairman to sign the Opioids Settlement Participation Form (collectively "Janssen"). The Opioids Settlement has one more Opioids Settlement Participation Form (collectively "Settling Distributors") which also needs authorization to participate in. Motion Grotelueschen; second Mejstrik to authorize the chairman to sign the Opioids Settlement Participation Form (collectively "Settling Distributors"). Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

The sheriff reviewed the state bid for two 2022 Police Utility Vehicles. Motion Wendt; second Mejstrik to approve the state bid with Anderson Ford of Lincoln for two 2022 Police Utility Vehicles in the amount of \$80,546.00. Voting YES: Wendt; Grotelueschen and Mejstrik. Voting NO: None. Motion carried.

Motion Grotelueschen; second Wendt to approve the following claims and issue checks for them. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

Motion Grotelueschen, second Wendt to authorize the chairman to sign the Memorandum of Understanding for Broadband Infrastructure Development. Voting YES: Mejstrik, Wendt and Grotelueschen. The Zoning administrator gave a report of the activities of her department; the public hearing that was scheduled for this meeting will be held January 25, 2022.

The assistant highway superintendent gave a report of the activities of the road department; employee evaluations were completed. The public meeting for comments of projects to be placed on the 1- & 6-Year Road Improvement plan will be held in Clarkson on January 19, 2022.
