January 10, 2023 Commissioners Meeting Minutes

A meeting of the Board of Commissioners of Colfax County, Nebraska was held in the Commissioners Room of the County Courthouse, Schuyler, Nebraska on the 10th day of January 2023. The County Board of Commissioners met at 8:30 a.m. Present were: Carl Grotelueschen, Jim Mejstrik and Terry V. Wendt, County Commissioners, Rita M. Mundil, County Clerk and Bruce J. Prenda, County Attorney. Notice of this meeting was given in advance thereof by posting written notice in at least three different public places as shown by the Certificate of Posting Notice. The availability of the proposed agenda was communicated in the advance notice and in the notice to the board. Copies of the Open Meetings Act were posted and available to the public. All proceedings shown were taken while the meeting was officially convened and open to the public.

The chairman stated a copy of the Open Meeting Act statute is posted and available to the public.

Motion Mejstrik; second Wendt to approve the agenda. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

Motion Wendt; second Mejstrik to re-organize for 2023 and appoint Carl Grotelueschen to serve as county board chair and authorize Jim Mejstrik and Terry V. Wendt to sign documents in absence of county board chair. Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

No report from the general assistance clerk.

The clerk provided the board with a copy of her monthly fees and STOP revenue received.

The board received a copy of the monthly fee report and the yearly report of Local Drug Court from the district court clerk.

The sheriff's December monthly report was provided to the board and placed on file.

The board received a copy of the December public defender report.

The vet service officer provided his December monthly report and claim reimbursements for December 20, 2022, and January 3, 2023.

The weed superintendent position is still vacant. Interviews were held and the position was offered. The board asked a former weed superintendent if he could complete the annual State Report which is due at the end of the month. Motion Mejstrik; second Grotelueschen to appoint Bruce J. Prenda to fill the vacancy of county attorney full-time position which is a four-year term with his salary to be set by the board. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

Motion Wendt; second Mejstrik to renew the appointment of Mark Arps as Title VI/ADA Coordinator. Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

Motion Grotelueschen; second Mejstrik to approve the revised mileage rate of \$0.655 cents/mile for all reimbursable mileage incurred by county employees beginning January 1, 2023; further providing that the sheriff is permitted to charge an additional 3 cents/mile for paper service.
