The Budget Hearing for Colfax County, Nebraska was held in the open and public session on September 12, 2023, at 8:15 a.m. in the Commissioners Room of the County Courthouse, Schuyler, Nebraska. Advance notice of the hearings was given by publication in the Leigh World on September 6, 2023.

The Budget Hearing was opened at 8:15 a.m. by Chairman Grotelueschen for the purpose of hearing support, opposition, criticism, suggestions or observations of taxpayers relating to the proposed budget.

The Board Chairman announced that the open meetings act is posted on the wall in the Commissioner's room and a copy may be obtained from the County Clerk's office upon request.

Present were: Carl Grotelueschen, Jim Mejstrik and Terry V. Wendt, County Commissioners and Rita M. Mundil, County Clerk. No public was present.

The Clerk presented the final FY23-24 budget document and explained expenditures, revenues, transfers and the property tax request.

Motion Wendt; second Mejstrik to close the Budget Hearing at 8:20 a.m. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

The Special Hearing to Set Final Tax Request was opened at 8:20 a.m. by Chairman Grotelueschen for the purpose of hearing support, opposition, criticism, suggestions or observation of taxpayers relating to setting the final tax request.

Present were: Carl Grotelueschen, Jim Mejstrik and Terry V. Wendt, County Commissioners and Rita M. Mundil, County Clerk. One county official appeared for the hearing.

The Clerk informed the Board that this year's tax request of \$5,839,787.18 will require a levy of .254451 which is lower than last year's levy of .280353.

September 12, 2023 Commissioners Meeting Minutes

A meeting of the Board of Commissioners of Colfax County, Nebraska was held in the Commissioners Room of the County Courthouse, Schuyler, Nebraska on the 12th day of September 2023. The County Board of Commissioners met at 8:15 a.m. following the Budget Hearing in the Commissioners Room of the County Courthouse, Schuyler, Nebraska. Present were: Carl Grotelueschen, Jim Mejstrik and Terry V. Wendt, County Commissioners, Rita M. Mundil, County Clerk and Bruce J. Prenda, County Attorney. Notice of this meeting was given in advance thereof by posting written notice in at least three different public places as shown by the Certificate of Posting Notice. The availability of the proposed agenda was communicated in the advance notice and in the notice to the board. Copies of the Open Meetings Act were posted and available to the public. All proceedings shown were taken while the meeting was officially convened and open to the public.

Motion Grotelueschen; second Mejstrik to approve Resolution 9-12-2023(1) for Adoption and Appropriations of the FY23-24 county budget. Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

Stephanie Bell/Extension Educator reported the state fair had good representation from the County, and the school enrichment program has been advertised with numerous teacher requests received.

The Clerk provided the board with a copy of her monthly fees and STOP Revenue received. Correspondence from NIRMA notifying the Annual Membership Meeting and Luncheon will be October 20, 2023, at the Younes Conference Center North in Kearney in conjunction with NIRMA's annual Self Defense conference for County Officials. Nomination/Election of NIRMA Board Members form needs to be returned to the NIRMA office by September 25, 2023.

The board received a copy of the monthly fee report from the District Court Clerk.

The Vet Service Officer provided his August Veteran Service Office report and claim reimbursements for August 29, 2023, to be placed on file.

The Sheriff's August monthly report was provided to the board and placed on file.

The board received a copy of the August Public Defender report.

The inmate log from Platte County was provided to the board and will be placed on file.

The County Attorney reported on reimbursement from Washington County for NLETC sheriff deputy training costs paid by Colfax County toward a recently resigned Colfax County trainee.

The board provided an opportunity for county employees to attend an "Agenda-less meeting".

A letter of resignation from the General Assistance Clerk was presented to the board. Motion Mejstrik second Grotelueschen to accept the written resignation of Lisa Svehla, General Assistance Clerk effective September 6, 2023. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

The County Clerk introduced Cristal Melgar to the board who will fill the Deputy vacancy in her office. She has placed an ad for full-time and part-time positions. Motion Wendt; second Mejstrik to approve Resolution 9-12-2023(5) for the appointment of Cristal N. Melgar as Deputy Clerk as of September 7, 2023. Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

Motion Grotelueschen second Wendt to appoint Cristal N. Melgar as GA Clerk effective September 7, 2023. Voting YES: Wendt, Grotelueschen and Mejstrik. Voting NO: None. Motion carried.

The Treasurer introduced Michele M. Root to the board. Motion Grotelueschen; second Mejstrik to approve Resolution 9-12-2023(6) for the appointment of Michele M. Root as Deputy Treasurer as of June 5, 2023. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

Motion Wendt; second Mejstrik to recommend approval for the special designated liquor permit to K & L Brass Rail LLC for an event on October 14, 2023, to be held at the Colfax County Fair Grounds. Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

The general assistance clerk gave a report of the activities of her department, no need to enter into executive session.

Bids for Project C19 (570) that were received by the 10:30 a.m. deadline were publicly opened and read. Five companies submitted bids. Discuss, consider and/or take action will be at the September 26th meeting.

A lengthy discussion was held on hard surfacing County Road 3.

The clerk summarized the day's agenda and action taken.
