Motion Grotelueschen, second Wendt to approve the 5-year extension of Interlocal Agreements with the libraries of Clarkson, Howells, Leigh, and Schuyler for continued county support in the fiscal year budget. Voting YES: Wendt, Grotelueschen and Mejstrik. Voting NO: None. Motion carried.

A discussion was held regarding the proposed county budgets for FY25-26, noting the May CPI at 2.4 percent. The Board approved a wage adjustment of 3% for hourly employees earning \$33.30 per hour or more, and a \$1.00 per hour increase for those earning less than \$33.30 per hour. It was emphasized that this action does not guarantee a 3% increase in January.

Discussion was held regarding who would print the postcards if any school, city, or county exceeds the 2% budget allowance. The Nebraska Department of Administrative Services has an agreement with MIPS for this purpose. Motion Mejstrik; second Grotelueschen to approve MIPS to print Colfax County postcards. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

Recessed at 10:00 a.m. to resume at 10:05 a.m.

The Zoning Administrator provided an update on recently issued permits.

Motion Mejstrik; second Wendt to open a public hearing at 10:05 a.m. for the purpose of hearing testimony of support, opposition, criticism, suggestions, or observation to amend Article 4 Section 4.19 FP – Floodplain Overlay District in the Colfax County Zoning Regulations. Voting YES: Mejstrik, Wendt and Grotelueschen. Voting NO: None. Motion carried.

The Floodplain Administrator noted that the current regulations have not been updated since 2017 and that an update was recommended during a recent audit by the Department of Natural Resources. The recommendation of the Planning and Zoning Commission is to approve Resolution 6-24-2025(2) Amendment of Article 4 Section 4.19 FP – Floodplain Overlay District.

No opposition to amending of Article 4 Section 4.19 FP – Floodplain Overlay District was given.

Motion Wendt; second Mejstrik to close the public hearing at 10:10 a.m. Voting YES: Wendt, Grotelueschen and Mejstrik. Voting NO: None. Motion carried.

Motion Grotelueschen; second Wendt to accept the recommendation of the Planning and Zoning Commission and approve Resolution 6-24-2025(2) Amendment of Article 4 Section 4.19 FP – Floodplain Overlay District. to the Colfax County Zoning Regulations. Voting YES: Grotelueschen, Mejstrik and Wendt. Voting NO: None. Motion carried.

The Highway Superintendent met with the Board to discuss the Barnholdt and Byrne drainage ditches and a potential partnership with the Lower Elkhorn NRD regarding erosion control along Maple Creek. Representatives from Murphy Tractor and Nebraska Machinery presented quotes and addressed questions related to the purchase of a new motor grader. Discuss, consider, and/or take action will take place at the July 8th meeting.

The County Clerk summarized the day's agenda and action taken.

The Board conducted valuation protest hearings with property owners.
