RESOLUTION 11-23-2021 (5)

WHEREAS, Nebraska Revised Statute Section 23-151 (Reissue 1997) provides that each county shall be divided into districts embracing as nearly as possible an equal population of the County; and,

WHEREAS, the County of Colfax is presently divided into three districts each embracing as nearly as possible an equal division of the population of the County of Colfax as based on the 2000 federal decennial census; and,

WHEREAS, the Colfax County Clerk has compiled information from the 2020 federal decennial census revealing an equal distribution of population; and

WHEREAS, based on the 2020 federal decennial census, it is the opinion and desire of the County Board of Colfax County, Nebraska, to change the districts within Colfax County as follows:

- A. Commissioner District Number One: Richland, Shell Creek, Wilson, Stanton, all that part of the City of Schuyler lying south of the center of Fifteenth Street and east of Fort Street and south of the center of Fourteenth Street and west of Colfax, and all that part of Schuyler Precinct lying south of the Union Pacific Railroad Right-of-way and west of Colfax Street (Highway 15), containing, 3,534 residents.
- B. Commissioner District Number Two: Grant, Midland, Adams, all that part of the City of Schuyler lying north of the center of Sixteenth Street, north Fifteenth Street, north of Fourteenth St and all that part of Schuyler Precinct north of the Union Pacific Railroad Right-of-way, containing 3,673 residents.
- C. Commissioner District Number Three: Rogers, Colfax, Maple Creek, Lincoln Precincts, and all that part of the City of Schuyler lying south of the center of Sixteenth Street and east of Colfax Street and all that part of Schuyler Precinct south of the Union Pacific Railroad Right-of-way and east of Colfax Street (Highway 15), containing, 3,375 residents.

NOW, THEREFORE, BE IT RESOLVED BY THE COLFAX COUNTY BOARD OF COMMISSIONERS, that the County of Colfax be divided into the following Commissioner Districts:

A. Commissioner District Number One: Richland, Shell Creek, Wilson, Stanton, all that part of the City of Schuyler lying south of the center of Fifteenth Street and east of Fort Street and south of the center of Fourteenth Street and west of Colfax, and all that part of Schuyler Precinct lying south of the Union Pacific

- Railroad Right-of-way and west of Colfax Street (Highway 15), containing, 3,534 residents.
- B. Commissioner District Number Two: Grant, Midland, Adams, all that part of the City of Schuyler lying north of the center of Sixteenth Street, north Fifteenth Street, north of Fourteenth St and all that part of Schuyler Precinct north of the Union Pacific Railroad Right-of-way, containing 3,673 residents.
- C. Commissioner District Number Three: Rogers, Colfax, Maple Creek, Lincoln Precincts, and all that part of the City of Schuyler lying south of the center of Sixteenth Street and east of Colfax Street and all that part of Schuyler Precinct south of the Union Pacific Railroad Right-of-way and east of Colfax Street (Highway 15), containing, 3,375 residents.

BE IT FURTHER RESOLVED BY THE COLFAX COUNTY BOARD OF COMMISSIONERS, that the attached hereto, marked Exhibit "A", and by this reference made a part hereof is a map showing each precinct and each Commissioner District and the approximate number of people in each precinct and Commissioner District which shall establish the boundaries as set forth herein.
